Convened by UN Women with the support of the Government of Canada through the Department of Foreign Affairs, Trade and Development, this platform aims to encourage knowledge and information sharing to support the application of gender equality principles, gender sensitive procedures, gender responsive practices within the judiciary in the region; and promote continuing dialogue on the application of CEDAW and other international human rights treaties in judicial system to safeguard human rights, promote access to justice and strong justice mechanism.

Designed to be an easy to use portal, this platform offers a variety of tools, such as e-discussion forums, guiding principles, training manual curriculum that integrates gender sensitive modules and quick fact sheets offering tailored learning solutions.
