Commission on the Status of Women (CSW)

The CSW is the principal global intergovernmental body dedicated to the promotion of gender equality and the empowerment of women. **During the Commission's annual** two-week session, UN Member States meet to evaluate progress on gender equality, set global standards and agree on further actions.
