UNCT CAMBODIA

The UN in Cambodia is positioned to advance Gender Equality while supporting the socio-economic recovery from COVID-19 and promoting the achievement of SDGs.

- Support the RGC to fulfill its obligations under CEDAW and invest in gender-equitable, inclusive and sustainable development strengthening implementation and financing of policies aimed to reduce inequalities in government operations.
- Work with and support civil society, Cambodian researchers, academics, and activists to generate evidence and data to advocate for advancing GEEW.
- Between Oct 2020 and Jan 2021, UNCT-SWAP Scorecard was conducted, jointly coordinated between UN Women (was a chair of GTG) and RCO.
- UNCT-SWAP was a collaborative/participatory self assessment process via GTG and a temporary IAT.

Criteria 1

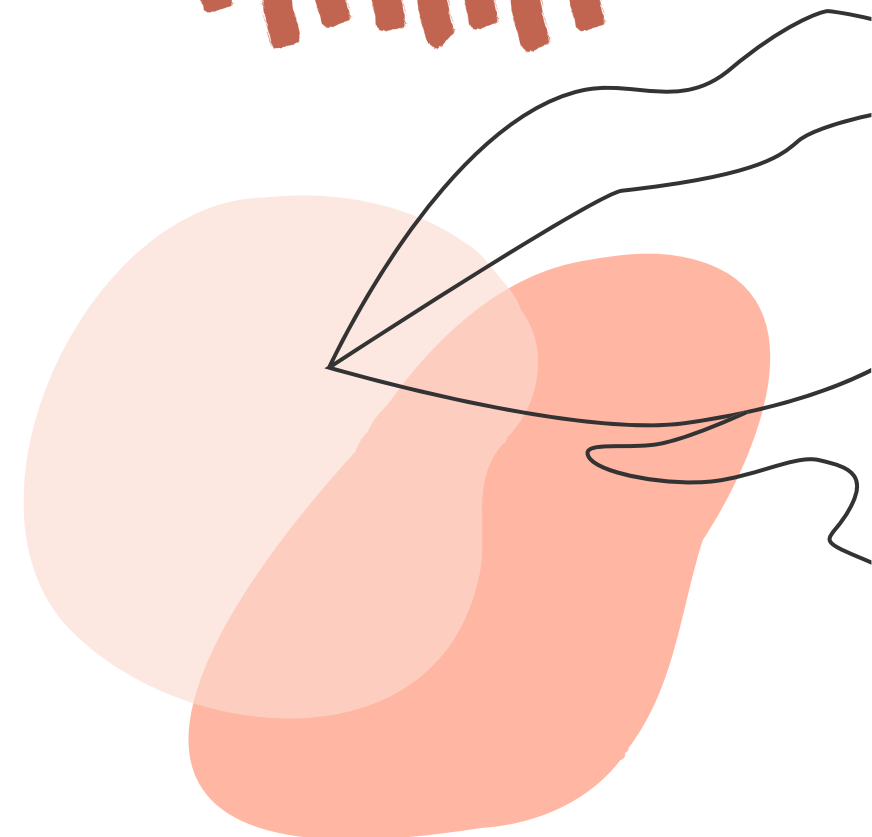
- UN agencies provided technical support for the development and implementation of NAPVAW (2019-2023), led by MoWA.
- The UN in Cambodia supported the RGC the finalization of National Strategy for Food Security and Nutrition (NSFSN) 2019-2023 ensuring gender is mainstreamed and priority actions reflect explicit objective for gender responsiveness and gender equality.

Criteria 2

- The MoWA participated in the Foresight and UN Vision 2030 workshops to develop the UNDAF (Jan 2018) and in various validation processes for Results Group development, particularly Results Group 4, and verified details of indicators. An evaluation of the UNDAF 2019-2023 began conducting since May 2022.

Criteria 3

- UNCT supported NIS/MoP on SDGs, gender statistics and gender disaggregated data
- UNCT supported Voluntary National Review (VNR), ensuring gender equality issues reflected.

Criteria 1

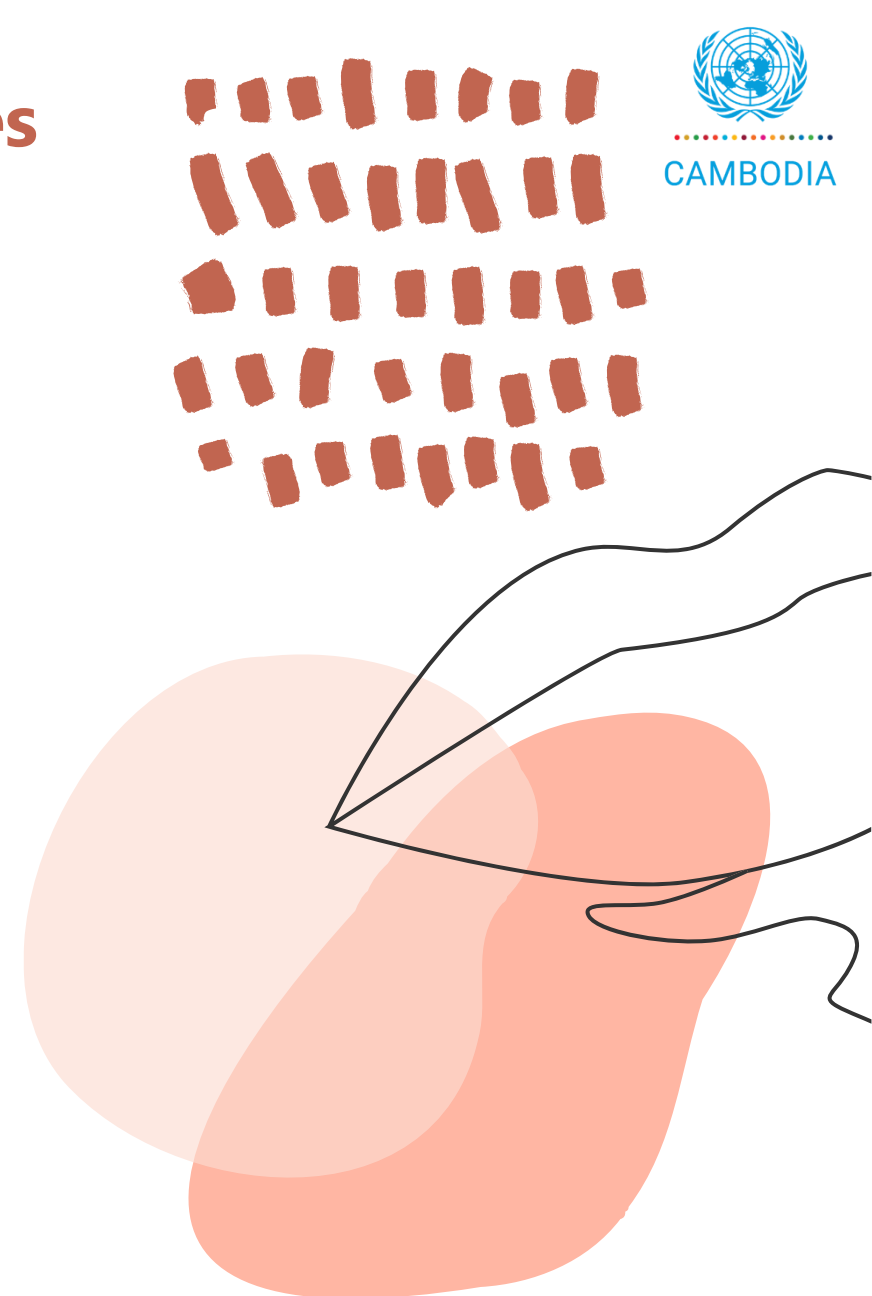
- Gender Equality and Empowerment of Women (GEEW)CSOs are the UN partners in monitoring the implementation of CEDAW concluding observations and the UN has also supported CSOs in drafting the CEDAW shadow report
- The UN facilitated GEEW CSO and women's advocates engagement in consultations and awareness raising activities and campaigns (IWD, 16 days campaign, Facebook GBV event, etc.)
- A joint UN effort with CSOs and LGBTQI community for a legal and policy assessment on key implementation barriers for LGBTIQ people to access health, HIV and social protection services.
- The UN continues to support a coalition for GE, through movement building and feminist transformative leadership approaches.

Criteria 2

- While GEEW CSOs participated in UNDAF consultations and Cambodia Common Country Analysis (2017 – 2019). However, they have not been involved in UNDAF monitoring process.

Criteria 3

- GEEW CSOs were involved in SDG localization consultations and 2019 VNR process; but space for meaningful contribution on gender related matters was limited. This is an area for improvement.

Process began with a PPT on UNCT-SWAP scorecard exercise at UNGTG meeting, and invited UNCG, RCO, OMT members to join. • Created an opportunity to reflect on UNCT performance 3.1 & 3.2 (Both UNGTG & UNCT) and encouraged to appreciate strengths and weakness of UNCT Performances 3.1 & 3.2. • UNCT providing coordinated support to MoWA and other line ministries on GEEW and deepens the engagement with the National Women's Machinery. • Ensure some IAT members (performance indicator 3.1 and 3.2) have "institutional memory or were engaged" in UNDAF / CCA processes (at least 2-3 years experience) • Through the SWAP Scorecard Exercise, UNCT has quickly discussed, collaborated and jointly developed concept notes/programmes to enhance gender equality. For example: concept notes/programmes (MPTF, EU Spotlight at country level, etc.) • UN GTG having regular meeting to reflect and discuss the progress, challenges and way forward including preparing action plan to maintain the UN commitments and performance in collaboration with the government for advancing GEEW. (Also applies to Indicator 3.2 recommendation by collaborating with civil society.)
