- d) The group has made substantive input into the UNSDCF including the CCA, Cooperative Framework design, results framework and M&E.



#### Meets Minimum Requirements

Meets 3 of the following:

- a) A coordination mechanism for gender equality is chaired by a HOA;
- **b)** The group has an approved TOR and annual work plan;
- c) Members include at least 50% senior staff (P4/NOC and above or equivalent);
- **d)** The group has made substantive input into the UNSDCF including the CCA, Cooperative Framework design, results framework and M&E.



#### Exceeds Minimum Requirements

Meets all of the following:

- a) A coordination mechanism for gender equality is chaired by a HOA;
- **b)** The group has an approved TOR and annual work plan;
- c) Members include at least 50% senior staff (P4/NOC and above or equivalent);

- Agencies agreed on having a gender strategy for the UNCT

#### **Objectives of Gender Strategy:**

- Enhance UNCT gender responsive programming and operational quality, effectiveness and efficiency;
- Identify priority areas for coordinated UNCT programming
- Inform Operationalization of the action-plan under the UNSDCF
- Set standards for gender sensitive monitoring and quality assurance
- Set standards for outreach and inclusion
- Support gender capacity development; and
- Institute accountability mechanisms.


#### **GTG & The Genesis of the UNCT Gender Strategy**

- Desk review/agency specific discussions (internal, bilateral for possible
- overlaps/duplications, opportunities & synergies)
- Meeting with co-chairs to share the outline of the strategy.

- The co chairs will share the outline in the PMT meeting with a deadline for inputs.
- Joint discussions (Theory of change)
- Validation of gender strategy & Finalization

#### GTG Financing Model – What the Model is?

resources are categorized as smaller, medium and large contributions ranging from 6% to 13%. The same formula was applied to the contributions as is used for UNDSS funding

GTG steered the process of Rapid Gender Assessment and developed sector specific gender guidelines for humanitarian response post 2022 floods

GTG leading the development of Gender Strategy for UNCT to ensure gender responsive programming, build capacities in required field and institute accountability mechanism

Developed interim CEDAW confidential report and leading the process of periodical CEDW confidential report

## Key achievements

Mainstreaming gender within the UNSDCF and providing technical assistance to operationalize OC2 on GEWE (coordination and thematic guidance to achieve commitments made under OC2, convening quarterly meetings to review progress and track results)
