Approaches Minimum Requirements

a) Gender equality is visibly mainstreamed into at least 50 percent of JPs operational at the time of assessment.

- GEM tool integrated in the UNSDCF JWP

? Why?

- Standardize and simplify (GEM questions were developed in close consultation with GEM Helpdesk and endorsed by UNCT)
- Promote ownership among UNCT members
- Use data/evidence for strategic learning
- Ensure UNCT's accountability on GEWE



- Offline template for UNSDCF Joint Work Plan – integration of GEM questionnaires
- In-house orientation/learning session
- UN agencies provide data for UNSDCF Joint Work Plan – including responses to GEM questionnaires
- Review and quality assurance of GEM application
- Assign GEM scoring to all projects/programmes

Process

- A total of seven questions related to integration of gender in the programme/project have been included in the offline UNSDCF Joint Work Plan (sub-outputs)
- In-house orientation organized on the application of GEM in programmes/projects
- Data collected from UN agencies including on the GEM application
- Quality assurance of GEM application (based on responses from UN agencies)
- Assignment of GEM scores

Key lessons from Phase I

- All PUNOs need to be engaged from the planning and targeting
- Synergies among PUNOs need to be translated in the ground (implementing partners)
- National Coordinators role to foster, nurture and facilitate coherence
- Investment in developing/strengtheni ng relationships amongst PUNO focal points
- Multi-year funding for more strategic planning

Challenge







- Discrepancies on data (GEM application) GE commitments vs resource allocation
- Over-coding of GEM
- Difficulty in generating data from UN INFO
- Ensuring common understanding of the GE priorities among PUNOs of joint programmes
- Internal contest among UN agencies in case of joint programmes

Lessons Learned





- Learning and sharing culture within UNCT to ensure common understanding of GE issues/priorities
- Invest in developing/strengthening relationships between PUNOs regular check-ins/follow ups at technical level (project managers)
- Synergies between PUNOs should be translated on the ground through coordination among implementing partners



Success Factors

Consultative process – coordination across inter-agency working groups (Outcome Result Groups, UNCT M&E and LNOB GESI WG)

Ownerships from UNCT members – UNSDCF Joint Work Plan

Simplified and standardized GEM questionnaires

Demonstration of jointness – design and implementation of joint programmes

Learning and sharing culture among UN agencies on what works well and what does not

Integrated approach to joint programming – bringing comparative advantages together

Speaking the same language by all PUNOs – Government's ownership
