# MOBILIZING INVESTMENT FOR RENEWABLE ENERGY AND WOMEN'S ENTREPRENEURSHIP

UNEP, through EmPower, has committed to raise USD 20 million in investments for renewable energy technologies and interventions that are gender-responsive and uphold the principle of leaving no one behind. To achieve this target, EmPower is partnering with financial institutions and collaborating with existing regional initiatives. An investor forum with regional actors will be held to identify and commit to investment in renewable energy initiatives.

EmPower works with financial institutions at the national and regional levels to design gender-responsive financial products, seeking to make financing more accessible to women and other marginalized groups. This is achieved through leveraging and mobilizing resources to support women entrepreneurs and women-led micro, small, and medium-sized renewable energy-based enterprises, including those from marginalized communities.



#### **TARGET GROUPS**

- I. Women-owned/women-led enterprises as defined below
- Other marginalized groups, including the poorest, most at-risk to climate impacts, ethnic minorities, Indigenous groups, LGBTIQ+ individuals and communities, refugees, internally displaced persons, migrants, people with disabilities, and people living with HIV.

#### Women-owned enterprise

An enterprise qualifies as a woman-owned enterprise if it meets the following criteria:

A. ≥ 51% owned by woman/women; or

#### Women-led enterprise

B. ≥ 20% owned by woman/women; and (i) has ≥ I
woman as CEO/COO/C-suite positions or equivalent;
and (ii) has ≥ 30% of the board of directors composed of women, where a board exists; or

#### **Employment**

30-50% share of women in the workforce and/or one "quality" indicator beyond compliance; and

#### Consumption

Product/s or service/s that specifically or disproportionately benefit women and other vulnerable or marginalized groups, i.e. the poorest, at risk of climate impacts, most vulnerable and marginalized, including ethnic minorities, Indigenous groups, LGBTIQ+ individuals and communities, refugees, internally displaced persons, migrants, people with disabilities, and people living with HIV.

#### Eligible size of enterprises

EmPower targets <u>micro, small and medium-sized</u> <u>enterprises (MSMEs)</u> that fall within the target group described above.

#### Eligible technologies under EmPower

Only clean technologies are supported through EmPower. Under EmPower, a technology is classified as clean if it contributes to mitigating  $\mathrm{CO}_2$  and other greenhouse gases. This includes carbon avoidance, such as renewable energy, fuel-switching, energy efficiency and waste management, as well as technological carbon removal, such as carbon capture and storage. Other clean technologies may also be eligible after a close assessment by UNEP.



#### SKILL DEVELOPMENT

EmPower supports skill development and capacity building for women entrepreneurs and women-led micro, small and medium enterprises from marginalized groups through e-learning, start-ups and business incubation programmes in renewable energy.

# SUPPORTING THE IMPLEMENTATION OF GENDER-RESPONSIVE CLEAN ENERGY POLICIES

Together with clean energy policy makers at national and regional levels, EmPower is working to:

- Support the implementation of existing policies
- Promote evidence-driven decision-making and provide technical assistance to further refine policies and support the monitoring and evaluation
- Increase the capacity of policymakers to apply knowledge and skills on gender and human rights in their work
- Increase the creditworthiness and credit rating schemes for women
