Terms & Conditions of the Planet 50-50 Comic and Cartoon Competition

By entering in this Competition, you agree to the below Terms and Conditions:

ARTICLE 1: Objective of the Competition

- 1.1 The Competition is organised by UN Women, EU Delegation and EU Member States Embassies (collectively "the Organising Entities"). The Competition is part of UN Women campaign "Planet 50-50 by 2030: Step It Up for Gender Equality". The Competition shall promote knowledge of 2030 Agenda for Sustainable Development (SDGs), particularly Goal 5: Gender Equality. The Competition invites people to familiarise with the SDG 5, achieving gender equality and empower all women and girls. SDG 5 consist of several targets, around which the Competition centers:
 - (a) End all forms of discrimination against all women and girls everywhere (b) Eliminate all forms of violence against all women and girls in the public and private spheres, including trafficking and sexual and other types of exploitation (c) Eliminate all harmful practices, such as child, early and forced marriage and female genital mutilation (d) Recognise and value unpaid care and domestic work through the provision of public services, infrastructure and social protection policies and the promotion of shared responsibility within the household and the family as nationally appropriate (e) Ensure women's full and effective participation and equal opportunities for leadership at all levels of decision making in political, economic and public life (f) Ensure universal access to sexual and reproductive health and reproductive rights as agreed in accordance with the Programme of Action of the International Conference on Population and Development and the Beijing Platform for Action and the outcome documents of their review conferences (g) Undertake reforms to give women equal rights to economic resources, as well as access to ownership and control over land and other forms of property, financial services, inheritance and natural resources, in accordance with national laws (h) Enhance the use of enabling technology, in particular information and communications technology, to promote the empowerment of women (i) Adopt and strengthen sound policies and enforceable legislation for the promotion of gender equality and the empowerment of all women and girls at all levels.
- **1.2** All entries to the Competition must be inspired by SDG 5 and/or nine targets of SDG as referred to above. Entries deviating from the above shall automatically be disqualified.

ARTICLE 2: Terms of participation

- **2.1** Entry is open to Indonesia nationals age 18 and above, who are residents of Indonesia. Entry to the competition is free.
- **2.2** You may enter up to two drawings but only one prize per person will be awarded. You must enter all of your drawings at the same time. You can only enter your drawing(s) once.
- **2.3** You must submit your drawing(s) by midnight (24:00 WIB) 21 October 2016 at the latest. Late entries will not be accepted. Drawings should be submitted by <u>e-mail</u> to: <u>registry.indonesia@unwomen.org</u>. You *must* mention "Submission for Comic and Cartoon Competition" in the title of your e-mail. Due to the expected high volume of last-minute entries, we advise you to enter your drawing(s) well in advance of submission deadline.

The organising entities cannot be held responsible for possible delays and/or errors by e-mail.

- **2.4** Together with the drawing(s), you must submit a brief explanation on the artworks and a copy of a valid and official ID.
- **2.5** Maximum of 20 semi-finalists will be selected by a judging panel of at least three members. The decision of all prize winners will be notified by e-mail after the judging is complete.

- **2.6** If you receive a notification e-mail from the Organizers, you must respond to the notification e-mail to accept your prize. If the Organisers do not receive a response from you within seven days of the notification, the Organisers reserve the right to reallocate the prize to another participant.
- **2.7** Names of the prize winners will be publicly announced at an award ceremony on 25 November 2016 in Jakarta, Indonesia. The prizes are set out below:
 - One 1st prize: MacBook Pro + RIXA Comic Package
 - One 2nd prize: Wacom tablet +RIXA Comic Package
 - One 3rd prize: Iphone + RIXA Comic Package
- **2.8** The three finalists will be invited to Jakarta for the award ceremony on 25 November 2016. The costs for travel within Indonesia will be borne by the Organising Entities. Travel costs from outside Indonesia cannot be funded.

The prizes and the invitation to the awards ceremony are non-transferrable and cannot be exchanged for cash.

- **2.9** The decisions of the jury are final and binding. Criteria's assessed are: relevance to the theme; technique; composition.
- **2.10** The Organising Entities reserve the right to cancel, modify, suspend or delay the Competition in the event of unforeseen circumstances beyond their reasonable control. The Organising Entities reserve the right to change, amend, delete or add to these Terms and Conditions at any time.
- **2.11** The Organising Entities and their officials and agents shall not be responsible or liable for any claims, demands, losses and liability of any kind or nature arising out of or in connection with your participation in this Competition or your acceptance or use of the prizes awarded.
- **2.12** The participants drawings may be considered for exhibition as well as for further publication.

ARTICLE 3: Eligibility of participants and drawing

3.1 Eligibility of participants

- **3.1.1** You must be at least 18 years old on 5 August 2016.
- **3.1.2** You must be an Indonesian nationals and a resident of Indonesia.
- **3.1.3** You must provide a copy of your ID which indicates your age/ date of birth and residence when submitting the drawing(s).
- **3.1.4** You must use your legal name and provide valid contact details along with your drawing(s).

3.2 Eligibility of drawing

- **3.2.1** The drawing(s) must not include words.
- **3.2.2** Your drawing(s) must fit on one DIN A4 page (210mm x 297mm). Both portrait and landscape orientation are accepted. If a drawing comprises several pictures, the number of the pictures should not exceed six boxes and the complete drawing must fit on one DIN A4 page.
- **3.2.3** The resolution of the drawing(s) must be 150 dpi or higher. Data size is limited to <u>20MB</u> per drawing. We accept jpg, jpeg, png, and pdf formats.
- **3.2.4** Your drawing(s) must not in the determination of the Organising Entities:
- be disrespectful of the impartiality and independence of the United Nations;
- reflect adversely on the Organising Entities;
- be incompatible with the aims and objectives of the Organising Entities;
- be derogatory to any existing person depicted in the drawing;
- contain any nudity, lewd, or otherwise offensive or inappropriate content.

The Organising Entities shall not be responsible or liable for: a) any problem, loss or damage due to delay and/or failure in receiving and sending the entry as a result of any network, communication or system interruption or error, or b) any error, interruption, deletion, defect, delay in operation or transmission, or unauthorised access to entries.

- **3.2.5** Submitted drawing(s) must be original, unpublished work. Entrants represent and warrant that their Submission is their original work, it has not been copied from others, and it does not violate the rights of any other person or entity.
- **3.2.6** Incomplete entries or entries that do not comply with these Terms and Conditions will be automatically disqualified at the sole discretion of the Organising Entities.

Article 4: Copyright

4.1 All Competition entries become the property of the Organising Entities and will not be acknowledged or returned. The copyright in any submitted drawing(s) shall remain the property of the entrant, but entry in this Competition constitutes entrant's irrevocable, perpetual permission and consent to the Organising Entities and others authorized by the Organising Entities without further compensation or attribution, to use, distribute, reproduce, re-exhibit or otherwise utilize the Submitted drawing(s) in whole or in part, and the entrant's name and city and state, by any means or methods now known or hereafter devised in any and all media now in existence or hereinafter created, throughout the world, for the duration of the copyright in the drawing(s). The entrant also consents to the Organising Entities doing (or omitting to do) any acts in respect of the submitted drawing(s) which may otherwise constitute an infringement of the entrant's moral rights. Organising Entities and/or others authorized by the Organising Entities shall have the right to edit, adapt, and modify the submitted drawing(s). No compensation will be paid to the artist in case of the publication of the competition entry.

Article 5: Indemnification

5.1 By entering your drawing(s) in the Competition you agree to indemnify, defend, and hold and save harmless, the Organising Entities, and its officials, agents, employees, consultants, sub-contractors and other representatives from and against all suits, proceedings, claims, demands, losses and liability of any kind or nature brought by any third party against Organising Entities, including, but not limited to, all litigation costs and expenses, attorney's fees, settlement payments and damages, based on, arising from, or relating to the Organising Entities' use of the drawing(s). The obligations under this section do not lapse upon closure of the Competition.
